



PRIVACY POLICY

Recovery Works San Diego (“**Recovery Works San Diego**“) operates <https://www.recoveryworkssd.com> and may operate other websites. It is Recovery Works San Diego’s policy to respect your privacy regarding any information we may collect while operating our websites.

WEBSITE VISITORS

Like most website operators, Recovery Works San Diego collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Recovery Works San Diego purpose in collecting non-personally identifying information is to better understand how Recovery Works San Diego visitors use its website. From time to time, Recovery Works San Diego may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Recovery Works San Diego also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <https://www.recoveryworkssd.com> blogs/sites. Recovery Works San Diego only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

GATHERING OF PERSONALLY-IDENTIFYING INFORMATION

Certain visitors to Recovery Works San Diego websites choose to interact with Recovery Works San Diego in ways that require Recovery Works San Diego to gather personally-identifying information. The amount and type of information that Recovery Works San Diego gathers depends on the nature of the interaction. For example, we ask visitors who sign up at <https://www.recoveryworkssd.com> to provide a username and email address. Those who engage in transactions with Recovery Works San Diego are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Recovery Works San Diego collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor’s interaction with Recovery Works San Diego. Recovery Works San Diego does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

AGGREGATED STATISTICS

Recovery Works San Diego may collect statistics about the behavior of visitors to its websites. Recovery Works San Diego may display this information publicly or provide it to others. However, Recovery Works San Diego does not disclose personally-identifying information other than as described below.

PROTECTION OF CERTAIN PERSONALLY-IDENTIFYING INFORMATION

Recovery Works San Diego discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Recovery Works San Diego behalf or to provide services available at Recovery Works San Diego websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Recovery Works San Diego websites, you consent to the transfer of such information to them. Recovery Works San Diego will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Recovery Works San Diego discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Recovery Works San Diego believes in good faith that disclosure is reasonably necessary to protect the property or rights of Recovery Works San Diego, third parties or the public at large. If you are a registered user of an Recovery Works San Diego website and have supplied your email address, Recovery Works San Diego may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Recovery Works San Diego and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Recovery Works San Diego takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

COOKIES

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Recovery Works San Diego uses cookies to help Recovery Works San Diego identify and track visitors, their usage of Recovery Works San Diego website, and their website access preferences.
